## EU/Single Market: Commission proposes new Services Package to boost growth and jobs

On 10 January 2017 the European Commission published a Services Package aimed at impacting on the services sector, which counts for the 70% of the EU GDP and 90% of jobs. The package foresees a set of proposals that will help service providers to work cross-border, thus reducing administrative and compliance costs for businesses, especially SMEs, lowering prices and giving a wider choice to consumers. The proposal for a European Services e-Card, through its fully electronic and multilingual procedure indeed aims at reaching this goal. The other two proposals, concern a binding proportionality test to be taken by MS before proposing new rules at the national level on professional services and an improved notification procedure. It further envisages guidelines for national reforms in the regulation of professions, offering guidance to MS for the opening up of legal, architectural and engineering professions which have a high growth potential for the economy.

### EU/Maltese Presidency: EU's Smallest Member State takes the Rotating Presidency

On 1 January 2017, faced with challenges ranging from populists from both the political spectra, to the Brexit and a set of elections in 2017, Malta, the EU's smallest Member State took the EU rotating Presidency. The rotating Presidency, is divided into a trio of Member States who rotate the position every 6 months, for 18 months, thus ensuring an agreed form of continuity in the trio's agenda. Inspired by the will to restore trust in the Union and its institutions, the Maltese Presidency's priorities are migration, the Single Market, security, social inclusion, the European neighbourhood and the maritime sector. Malta will be at the centre for the next 6-months as the Brexit negotiations are set to begin, in March, where the island nation will seek to return the citizen to the heart of the European project.

# EU/Labour regulation: France to require posted workers to have a professional card in order to fight posting fraud

On 4 January 2017, French Prime Minister Bernard Cazeneuve and Labour Minister Myriam El Khomri handed the first professional card issued to a posted worker in Bretagne. Following Macron's 2015 economic reform bills, starting in February 2017, posted workers in France will be required to have a professional card carrying a photo, personal and employer information, and a unique bar code that can be read by inspectors using a mobile application. The goal of the reform is increased worker protection and defence of the French social model, according to the French Prime Minister. The cards are set to be issued for more than 2 500 000 workers. This development comes as at the European level talks continue in the Parliament and Council towards the adoption of a revision of the Directive on the Posting of Workers. The EP's opinion is set to be voted in plenary in April, but at the moment it looks unlikely that Member States will reach consensus soon, as the proposal has caused a major rift between East and West European states since its release in March 2016, and had to go through a Yellow Card procedure in the summer of 2016, when the Commission decided to uphold it as it is.

### EU/Digital: Commission proposes strengthened ePrivacy rules.

On 10 January 2017, the Commission submitted its Proposal for the REFIT of the ePrivacy Directive. This new Proposal will target Over-The-Top (OTTs) communications services, which will now be covered by the regulations on Telecom. Moreover, the Proposal will tackle the ''cookie banner'', instead of having this banner appearing on almost every website, users will now have the possibility to set general privacy preferences putting an end to the overload of cookie banners. The Commission called on the Parliament and the Council for a swift adoption of its proposal, hoping for the legislative procedures to be completed by 25 May 2018.

# EU/Business: Uncertainty in the political sphere causes forecasts of cautious outlooks for business in 2017

On 11 January 2017, the first "Small Firms Outlook 2017" survey carried out by the Irish Small Firms Association (SFA), showed that business owners and managers are less positive about the business environment as we enter into the new year. While mid-2016 results showed 66% of them feeling that the business environment is improving, this number has now dropped to 50%. Specific sectoral opportunities, new products and new branding and marketing campaigns, as well as exports were among the factors presenting biggest opportunities for small businesses in 2017. Brexit and the newly elected American president, as well as cashflow issues and inflation were seen as major areas of concern for business owners, on the other hand.

The REACH REFIT evaluation (REACH Review 2017) will build on the findings of the first REACH Review (published in 2013) and examine key developments since then. The REACH REFIT evaluation (REACH review 2017), is carried out in line with the principles of Better Regulation and will cover the five compulsory evaluation criteria: effectiveness, efficiency, relevance, coherence and EU added value. A public consultation is planned to obtain stakeholders' views on the approach to the evaluation and collect any potentially missing elements. Furthermore, a specific consultation on SME relevant issues will be carried out through the Europe Enterprise Network (EEN).

# Public consultation on the functioning of mutual assistance between EU Member States for the recovery of taxes

**DEADLINE: 08/03/2017** 

The competence of tax authorities is limited to their national territory. They cannot take recovery actions in other countries, although tax debtors may have moved to another country or may dispose of assets in other countries. Therefore, the EU has adopted legislation which allows the EU Member States to provide mutual assistance to each other, for the recovery of their taxes. The European Commission is currently undertaking an evaluation of this legislation, as announced in its Action Plan on value added tax (VAT). This public consultation seeks the opinion of persons confronted with such recovery assistance procedures and other stakeholders.
