## In Italy

- we have more than 110,000 surveyors;
- they are all registered to the provincial professional orders;
- and from a national point of view they are all regulated by CNGeGL



# The Consiglio Nazionale Geometri e Geometri Laureati(CNGeGL):

- was established with the royal decree of 11th Febraury 1929, n.
   274;
- it represents the central selfgoverning body of the profession of surveyors;








## Composition of CNGeGL:

- 11 board members elected by the 110 Provincial Boards;
- the term of office of the board members is of 5 years and they can be re-elected

# The Legal System relies on CNGeGL representative, consultative and jurisdictional functions.

### **CNGeGL**

- a no-profit public body,
- it has an advisory role to the Government and Pariament,
- it presents proposals for improving the professional legislation;

It sends opinions and directives on the profession, ethics and training to even out the activities of the 110 provincial boards of Surveyors;



The Council's decisions are valid when the proposals obtained an absolute majority of the votes;

# National Organization:

 In each of the 110 Italian Provinces there is a provincial board of Surveyors;


• The activity of the Provincial Boards is regulated by law under the control of the Ministry of Justice;



#### The Provincial Boards:

- have to update the official registers;
- decide on the ethical behaviors of the registered surveyors;
- garantee the participation to the continuing professional development courses;
- act for the protection of the qualification and of the profession.






## CNGeGL signes agreements with national and local authorities:

- to promote the profession of Surveyors for improving their activity and results;
- to improve the technical and cultural skills through the continuing professional development;
- to ensure the quality of the professional services and the protection of the client;
- to ensure a growing recognition on behalf of the institutions;



# CNGeGL has comptence for the special jurisdiction in professional matters through the pronunciation of second-degree sentences:

- ✓ on appeal of the registered members against disciplinary measures taken by the Provincial Disciplines Boards in professional ethics issues;
- ✓ on the registration and/or cancellation from the Official Register adopted by the Provincial Boards;
- ✓ on complaints regarding the election of the Councils of the Provincial Boards.



- The activities of the Provincial Colleges and of CNGeGL is financed by fees paid by the registered members.
- Each board establishes the annual registration fee in relation to the necessary expenses for the keeping of the Official Register, the performance of its facilities and the fixed contribution for CNGeGL.
- The costs related to individual services (participation in training courses, certification, etc.) are paid to the College by the interested individual members.






# What are the competences of the Surveyors?

- Cadastre, Topography, Aerophotogrammetry;
- Real Estate Valuations;
- Technical Advice to private and judges;
- Projects of works for the protection of the environment and landscape;
- Certification of energy savings in building;
- Safety in construction;
- Design of fire prevention solutions.
